This Privacy Policy sets out the rules for the processing and protection of personal data provided by Users in connection with their use of services via the website WirtualnySpacer.online

Who we are

The administrator of personal data contained on the website is Borysław Pasierbski with its registered office in Szczecin at ul. Szafera 84/3.

What data do we process

Forms

The data provided in the form is processed for the purpose resulting from the function of a specific form via e-mail on the website WirtualnySpacer.online

Cookies

If you leave a comment on our site, you can consent to your name, email address and website being saved in cookies. These are for your convenience so that you don't have to fill in your details again when you leave another comment. These cookies will last for one year.

If you visit our login page, we will set a temporary cookie to determine if your browser accepts cookies. This cookie contains no personal data and is rejected when the browser is closed.

After logging in, we will also set several cookies to save your login details and on-screen display options. Login cookies last for two days and screen cookies last for a year. If you choose "Remember me", your login will be valid for two weeks. If you log out of your account, the login cookies will be deleted.

Who we share your data with

Your data is processed by the Borysław Pasierbski company with its registered office in Szczecin at ul. Szafera 84/3 and employees and representatives of WirtualnySpacer.online as well as entities providing postal, courier, banking, advisory, financial, accounting, tax, auditing, legal, sharing and processing economic information or providing WirtualnySpacer services to the company WirtualnySpacer.online. online hosting services or services related to IT systems and software.

How long do we process your data

Your personal data will be processed and stored for a period of 3 years from submitting the inquiry via the contact form, via e-mail or by phone.

What rights you have over your data

Personal data is processed on the basis of the consent expressed by the User and in cases where the law authorizes the Administrator to process personal data on the basis of legal provisions or to implement the contract concluded between the parties.

The data contained in the forms may be viewed by the person who placed them there. Pursuant to the provisions of the Personal Data Protection Regulation of May 25, 2018, the Regulation of the European Parliament and of the Council (2016/78) of April 27, 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data enters into force. and repealing Directive 95/46 / EC. The customer has the right to correct, supplement, update, rectify and request removal of his personal data.
